


Definition

- Medical or surgical termination of a pregnancy
- Before the Fetus is viable outside of the uterus



Reasons


- Violent/ abusive circumstances -> extreme cases : rape, incest, domestic abuse
- Desire to complete education/ focus on career
- Age (e.g. teenage pregnancy)
- Physical/mental health
- Financial aspect- inability to afford a child (lacking economic support)

Reasons

- Not compatible with personal family planning
- No stable relationship-difficulties of being a single mom (forced to take responsibility alone)
- Societal pressure: e.g. discrimination of people with disabilities;
- -Preference for specific sex, race
- Population control
- Disapproval of early/ single motherhood

Numbers and facts

- 73 million abortions worldwide per year
- 29% of all pregnancies end in abortion
- 61% of abortions caused through unintended pregnancies
- 45% of abortions are unsafe
- More than 50% of unsafe abortions take place in Asia
- 3 out of 4 abortions in Latin America and Africa are unsafe

Safe methods


- Possible till the 63rd day after the first day of the last period
- In exception even after the 12th week
- two options: surgical and medical method
- A doctor has to be present
- A consultation has to take place at least three days prior

Medical method

- Active substance: Mifepriston and Misoprostol
- Birth induced medically
- Intake of Mifepriston in the presence of a doctor
- -Possible symptoms: light bleedings, feeling sick, diarrhea
- 36-48h later intake of Prostagladin
- -Possible symptoms: heavy bleedings, period similar cramps
- After the 22nd week chance of survival
- -Fetocitial: administration of a cardiac paralytic injection

Surgical method ("vacuum aspiration")

- Possible from the 5th to the 14th week
- Outpatient or in a well-equipped clinic
- Anesthesia of the cervix and uterus
- Short anesthesia via vein
- Duration only a few minutes
- Insertion of a thin plastic tube into the uterus
- -Suctioning of uterine mucosa and uterine lining
- -Possible symptoms: period like cramps, light bleeding



unsafe methods

- Usage of contraceptives
- Usage of sharp objects
- Insertion of herbal preperations or foreign bodies
- Jumping from heights to cause blunt trauma
- Places: clinics, chemist shops and homes
- Risks:heavy bleedings, infections, uterine perforation, damage to the genital tract and internal organs, injury, disability, death

Medical perspective on pregnancy

- Fertilization (Conception): DNA is formed in the zygote, beginning of human biological development, considered biologically alive.
- (-> described as potential human, single cell)
- Embryonic Stage (0–8 weeks): emybro undergoes rapid cell division and differentiation
- 4-6 weeks: basic body structures and organs begin to form (e.g. heart)

Medical perspective on pregnancy

- Fetal Stage (8 weeks-birth): continuous growth and development:
 - –Viability: Fetus capable of surviving outside the womb with medical intervention, independent existence (around 22–24 weeks gestation)
 - Brain Development: higher neurological functions(third trimester)
- Birth: Medically and legally fully recognized as a human being in with individual rights

Laws in Germany

- §218(StGB):
- · abortion is illegal except to save the life of the mother
- Punishable by up to 3 years in prison or a fine
- §218a:
- 1. Abortion is performed during the first 12 weeks of the pregnancy
- 2. 4 days after a consultation with a doctor
- 3. Procedure by a certified doctor

Laws in Germany

- §219: purpose of consultation -> give the woman a perspective on opportunities when carrying out the pregnancy, to protect unborn life
- New changes 2022:
- Bundestag repealed §219a: "advertising the termination of pregnancy" -> included spreading awareness about different methods and risks of abortion


What is Roe v. Wade?

- Jane Roe (fictional name), unmarried and pregnant woman in Texas
- Filed a lawsuit against Texan State (Henry Wade), fighting for abortion rights
- Reasoning: right to liberty (personal freedom) which includes personal privacy (choice over own body)
- Supreme Court decision 1973: legal right to access abortion nationwide
- Striking down Texas abortion ban as unconstitutional

Supreme Court decision 2022

- Dobbs v. Jackson Women's Health Organisation overturned Roe v. Wade
- Abortion regulations from now on decided by individual states
- Reasoning: constitution doesn't explicitly guarantee right to abortion (14th Amendment)
- First time Supreme Court has taken away a fundamental right

Current laws in different states



Different bans


- Trigger bans: ban abortion entirely
- Pre-viability gestational bans: prohibited abortion before viability
- Method bans: specific methods not allowed (dilation & extraction, dilation & evacuation)
- Reason bans: reasons like sex, race, genetic anomaly of the child
- **Self-managed abortions**: some states criminalize: end their pregnancy outside of healthcare system

Consequences of this ban

- Millions of women lost their right to abortion
- –e.g. Georgia: performing dialation and curettage (D&C) felony offence
- -Amber Nicole Thurman (28): desire to terminate twin pregnancy
- Clinic offered medical abortion
- -Symptoms: heavy bleeding, vomoting blood: acute, severe sepsis
- Operation delayed by 17 h -> abdominal surgery lead to death
- many protests

Consequences of this ban

- Increase of abortions in the US
- -15.9 per 1000 women (11% increase)
- Almost all states without total ban
- Reasons: increased financial support, other states improve protection and access, increased travel access



Consequences of this ban

- Further travel to abortion access
- More and more states pass bans
- Clinics, abortion funds, logistical support organisations try to create more access
- -Struggle with outer state increase
- −e.g. Illinois -> 26.000 more patients from out of state compared to 2020

Trumps contradictory positions

- Latest statement: Legalities should be up to the states
- Before: Months of discussing the possibility of federal abortion
- Extremely fast switching opinions on this subject
- Timetable of his views (only some excerpts of his statements)
- -1999: "I am very pro choice"
- -2011: "I am pro life" (drastically changed posture)
- -2016 : Requires "some sort of punishment for women, who seek abortion" -> votes to overturn Roe v Wade

Trumps contradictory positions

- -2023: Trump blames the abortiondiscussion for midterm losses
- -2023 : Vague promise regarding compromise
- -2024: Considers national abortion ban
- -2024 Most recent decision:Accountability depends on the states



Claims during the election campaign

- Trump's conspiracy theory: During presidential debate claim, that Democrats support abortion "after birth"+ "executing babies"
- Trumps intention: Painting Democrats as radical
- -The term for this is infanticide-> crime
- Lindsay Davis clarifies there is no state, in which this is supported by Democrats/legal
- Trump avoided an answer to the question, if he would sign a national abortion ban, or veto such a bill
- J.D. Vance (vice president) expressed clearly he would veto
- But: Not yet discussed between Trump and J.D. Vance

Trumps actions since his inauguration

- He downplays the issue
- By shutting down government-Website with information about reproductive rights

Updates:

- Trump administration plans to rejoin international anti-abortion pact alongside Saudi-Arabia, Uganda etc
- Reversing Bidens efforts to protect+ expand reproductive care access
- Blocking financial help for organizations, that mention abortion in their consultation

Contra

- Most pro-lifers believe life begins with conception
- No society permits humans to intentionally take life without punishment -> abortion is no different
- -Direct defiance of the idea of the sanctity of human life
- Cases of rape/incest: taking drugs after the event -> woman won't get pregnant: rather punish perpetrator than innocent unborn child
- Causes psychological pain amd stress for the women

Contra

- Many, who choose abortion are young women/ minors: don't understand what they are doing-> lifelong regret
- Potential for Exploitation:
- -pressure from family/partners could undermine real choice
- -can be used for gender selection
- convenience rather than necessity
- Rather give women a life perspective and show all opportunities
- Adoption: child still has a chance to a fulfilled life

Pro

- Ban leads to illegal unsafe abortions
- Right to life
- Right to highest attainable standard of health
- Right to benefit from scientific progress and ist realization
- Right to decide freely and responsibly on the number, spacing, timing of children
- Right to be free from torture, cruel, inhuman and degrading punishment

Pro

- If forced to give birth kid can feel unwanted and unloved
- Doesn't have caring parents mental health problems
- It is not a baby yet and depends on the mother ist not an own person yet

Law vs. Personal freedom

- Law: government has interest in protecting life and setting regulation on medical procedures
- Personal freedom: abortion as matter of bodily autonomy and privacy, right to make own decision
- Criminalization of abortion => Violation of human right of reproductive freedom

Personal Statement

- Everyone has the right to decide for themselves
- A ban is a violation of personal freedom
- The baby is not able to survive on its own yet not an own human being
- Everyone has the right to decide freely and responsibly on the number, spacing, timing of children and the law cannot take the right away
- Impossible to ban abortions, you are only banning the safe ones
